ARTICLES OF INCORPORATION OF THE NATIONAL CAPITAL TANDY COMPUTER USER'S GROUP INCORPORATED

In compliance with the requirements of Chapter 2, of Title 13.1 of the Code of Virginia, 1950, as amended, I hereby form a corporation not for profit and do hereby certify:

ARTICLE I

The name of the corporation is NATIONAL CAPITAL TANDY COMPUTER USER'S GROUP, INCORPORATED, hereafter called the "Corporation".

ARTICLE II

The registered office of the corporation is located at 5859 Glen Forest Drive, Falls Church, Virginia, 22041, Fairfax County, and P.O. Box 2826, Fairfax, Virginia, 22031.

ARTICLE III

The registered agent of the Corporation is Donald A. Gruenther, who is a resident of Virginia, over eighteen years of age, and is a director of the Corporation, and whose address is the same as the registered office.

ARTICLE IV PURPOSE AND POWERS OF THE CORPORATION

- a) National Capital Tandy Computer User's Group, Incorporated is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law.)
- b) The Corporation has the power to fix, levy, collect and enforce payment by any lawful means all dues and assessments established by the Board of Directors.

- c) The Corporation may acquire (by gift, purchase or other-wise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Corporation.
 - d) The Corporation may borrow money.
- e) The Corporation has, and may exercise any and all rights, powers and privileges which a corporation organized under the Virginia Non-Stock Corporation Act of the State of Virginia by law may now or hereafter have or exercise.

ARTICLE V

There shall be one class of membership. Any person who sub-scribes to the purposes of this organization may, upon application, be selected by the Board of Directors.

ARTICLE VI VOTING RIGHTS

A voting member shall be one who has paid all dues and assessments. Voting membership shall be for a period of one year and is renewable.

ARTICLE VII BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by a Board of thirteen (13) Initial Directors, who need not be members of the Corporation, and who shall serve for a term of one year. ARTICLE IX DISSOLUTION

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the organization, dispose of all of the assets of the organization exclusively for the purposes of the organization in such a manner, or to such organization(s) organized and operated for charitable, educational, or scientific purposes as at the time shall qualify as an exempt organization(s) under section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the organization is then located, exclusively for such organization(s), as said Court shall determine, which are organized and operated exclusively for such purposes.
